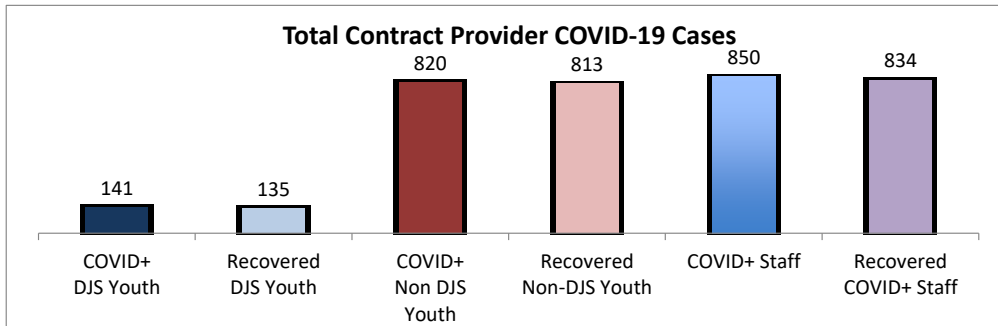


Overall COVID19 Cases To Date, December 30, 2022
