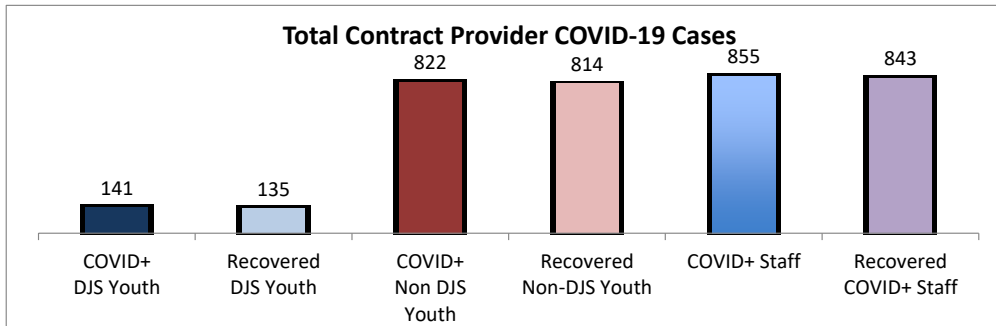


**Overall COVID19 Cases To Date, January 5, 2023**
