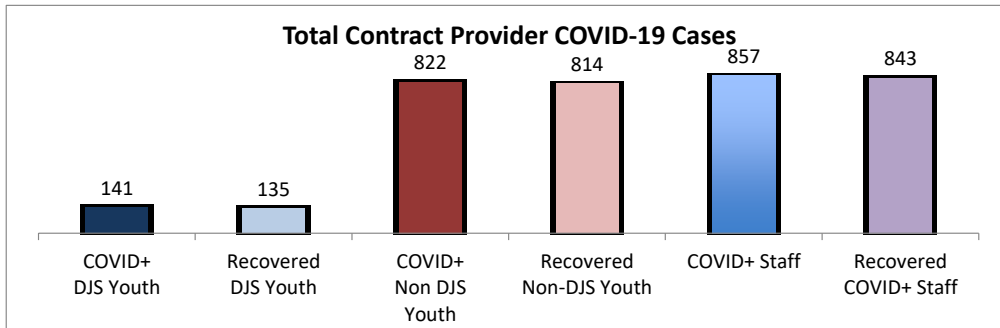


Overall COVID19 Cases To Date, January 9, 2023
