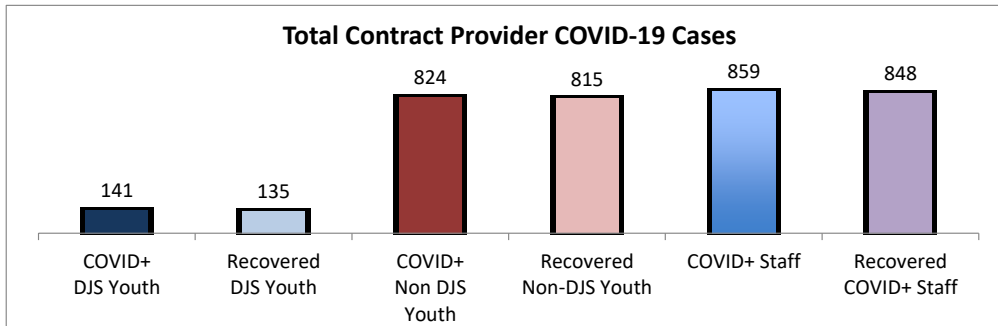


**Overall COVID19 Cases To Date, January 12, 2023**
