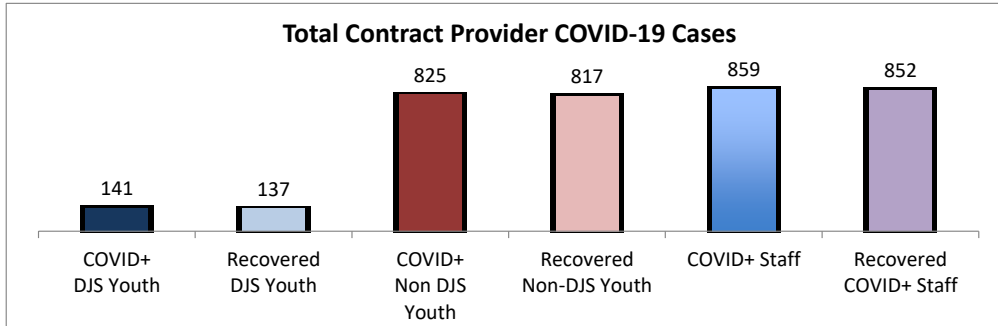


**Overall COVID19 Cases To Date, January 18, 2023**
