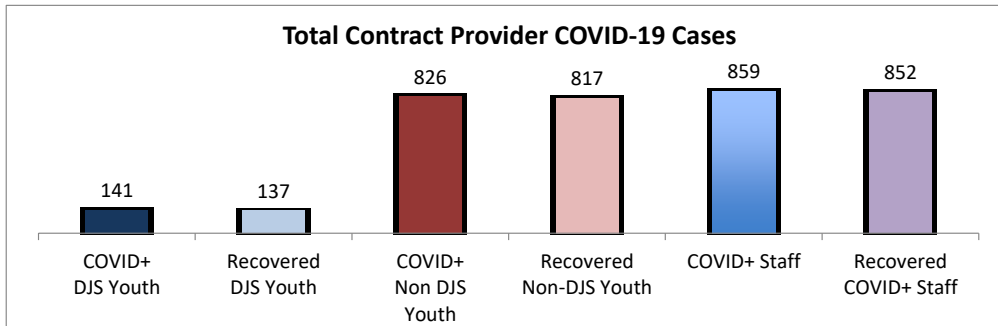


Overall COVID19 Cases To Date, January 20, 2023
