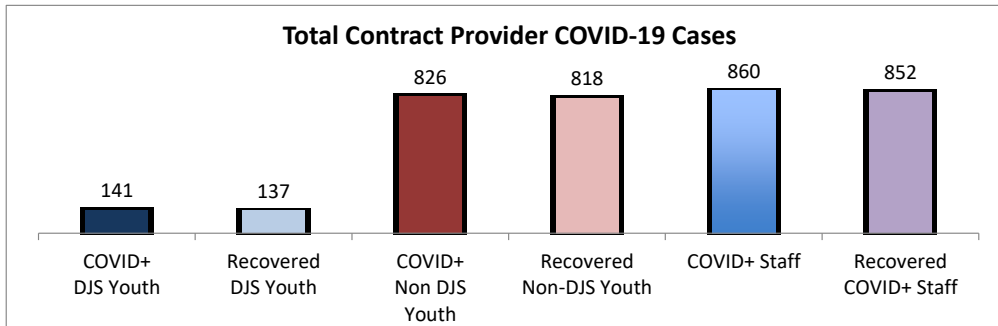


Overall COVID19 Cases To Date, January 25, 2023
