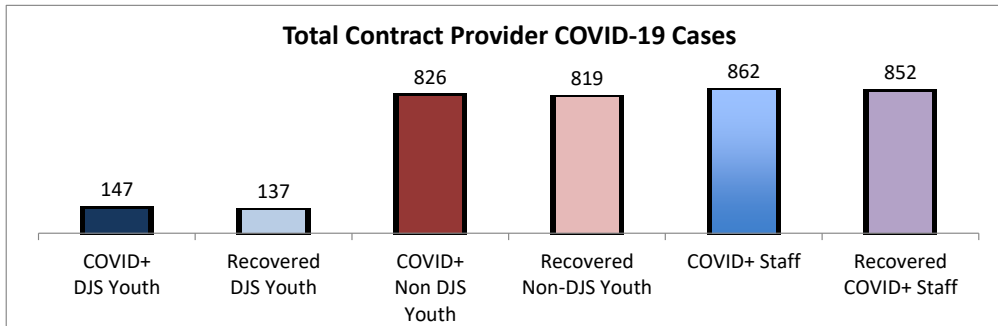


Overall COVID19 Cases To Date, January 31, 2023
