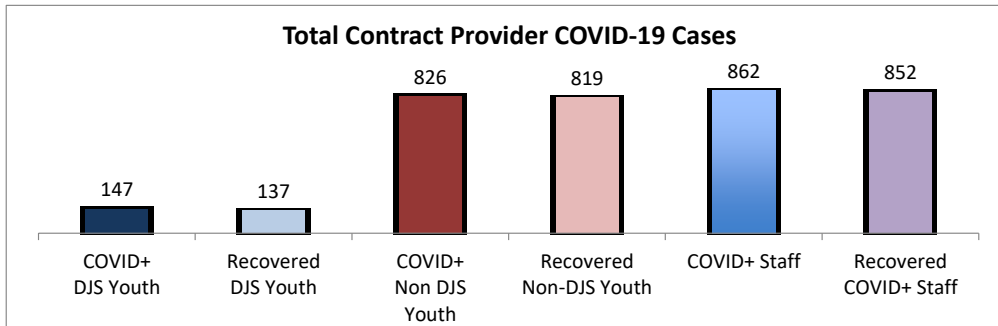


Overall COVID19 Cases To Date, February 1, 2023
