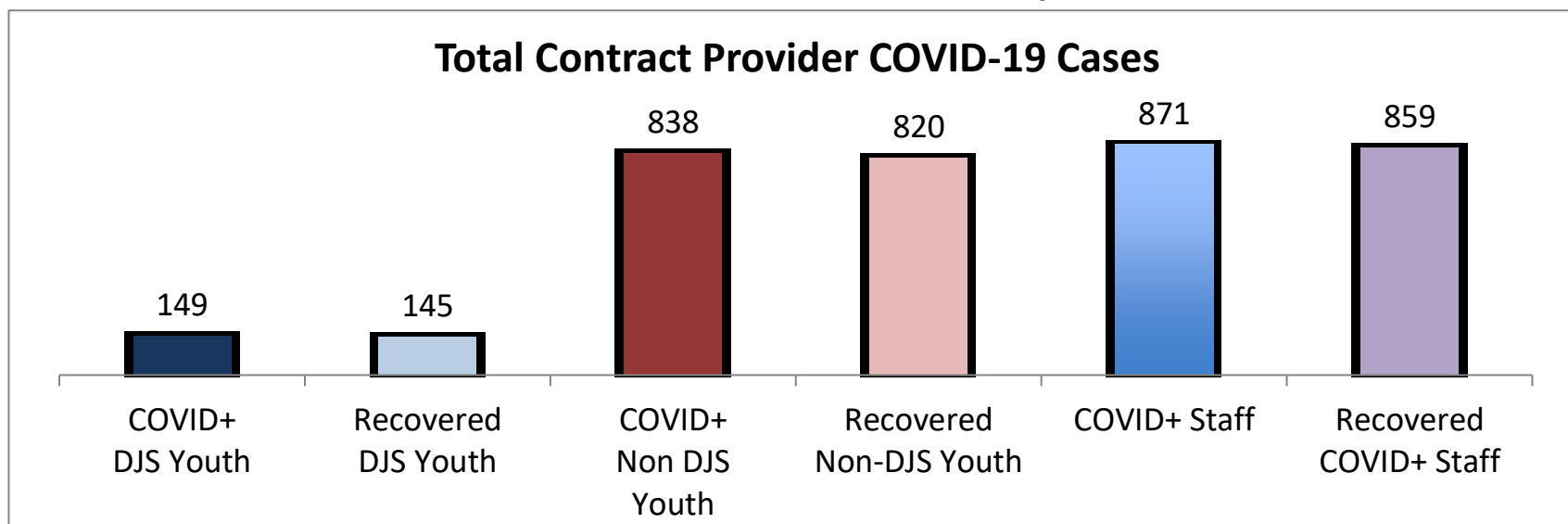


Overall COVID19 Cases To Date, February 10, 2023
