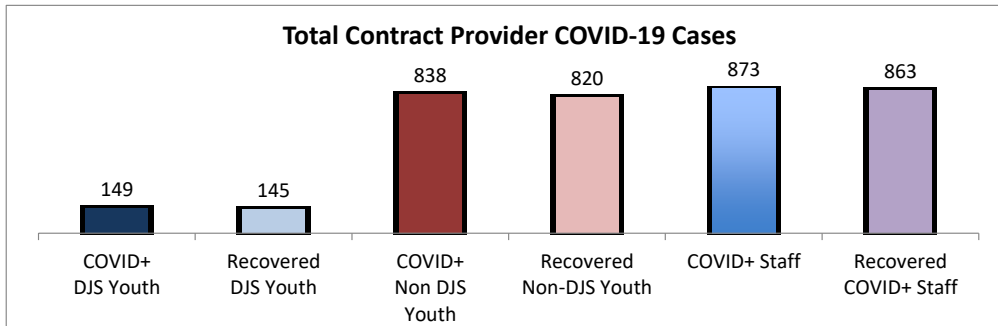


Overall COVID19 Cases To Date, February 15, 2023
