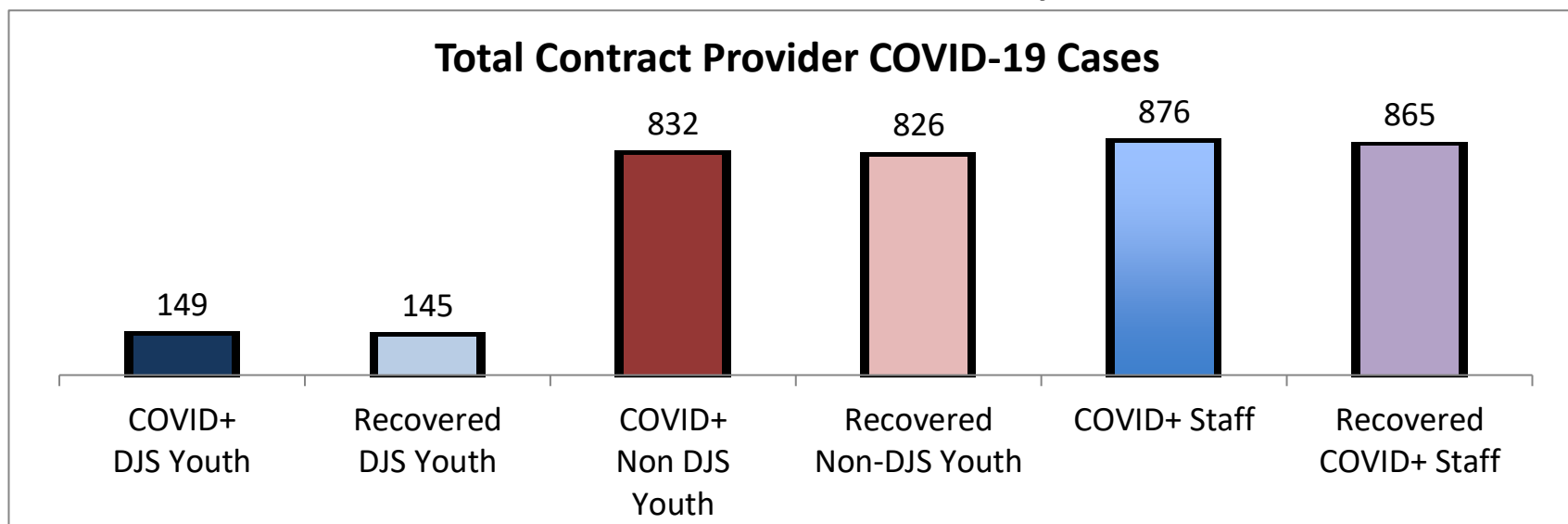


**Overall COVID19 Cases To Date, February 17, 2023**
