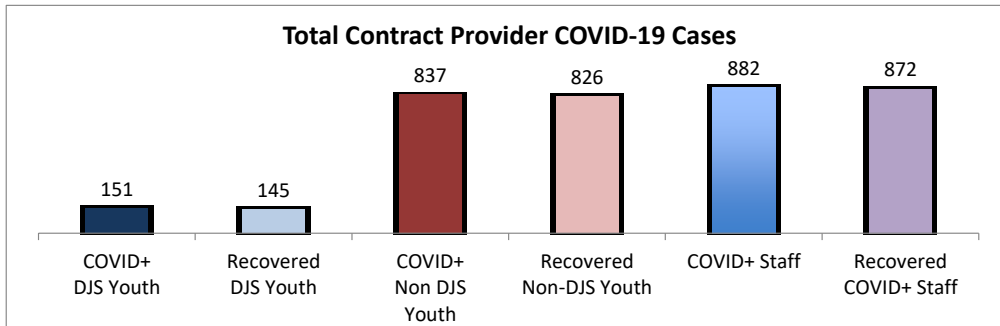


Overall COVID19 Cases To Date, February 27, 2023
