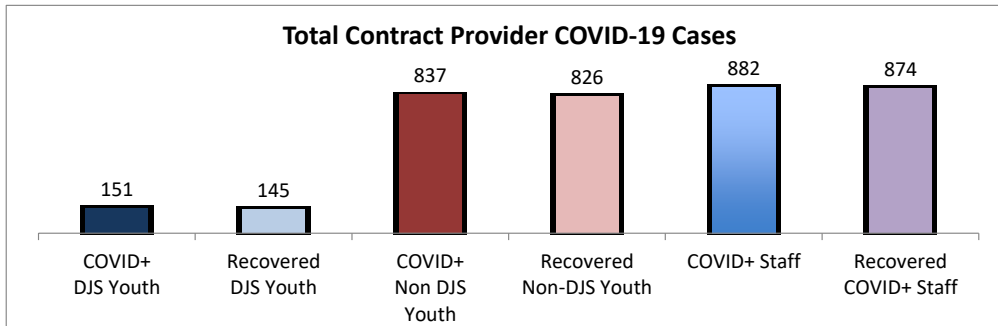


Overall COVID19 Cases To Date, February 28, 2023
