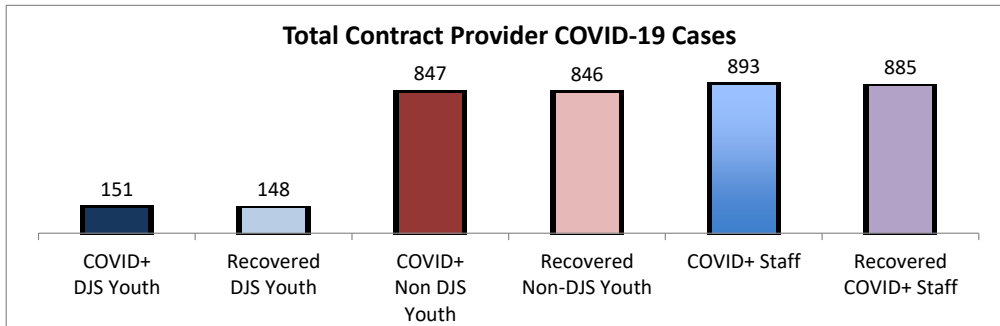


Overall COVID19 Cases To Date, March 10, 2023
