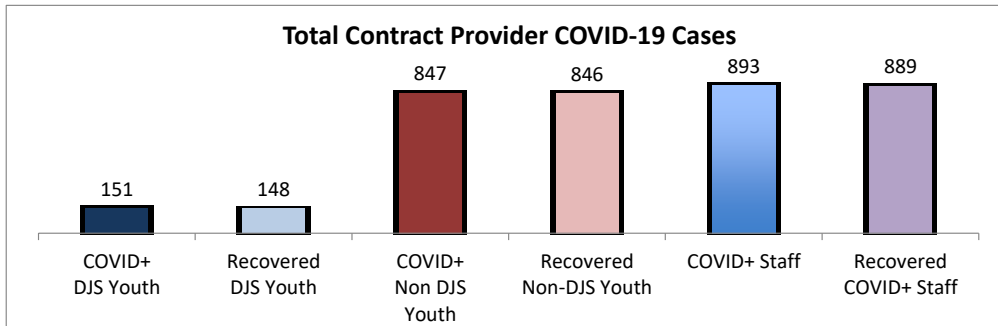


**Overall COVID19 Cases To Date, March 15, 2023**
