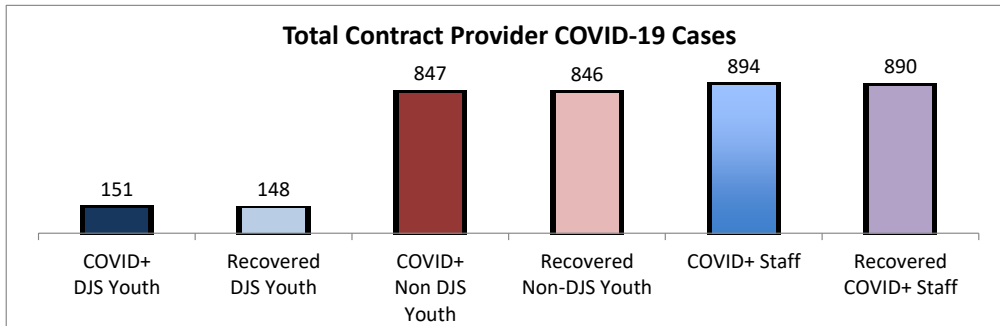


Overall COVID19 Cases To Date, March 24, 2023
