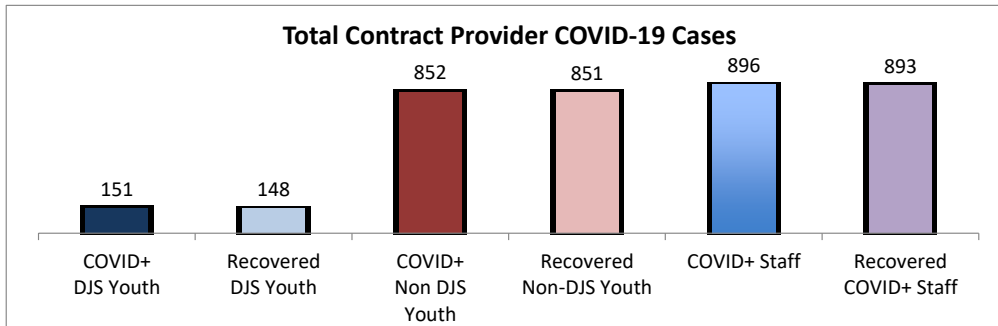


**Overall COVID19 Cases To Date, April 26, 2023**
