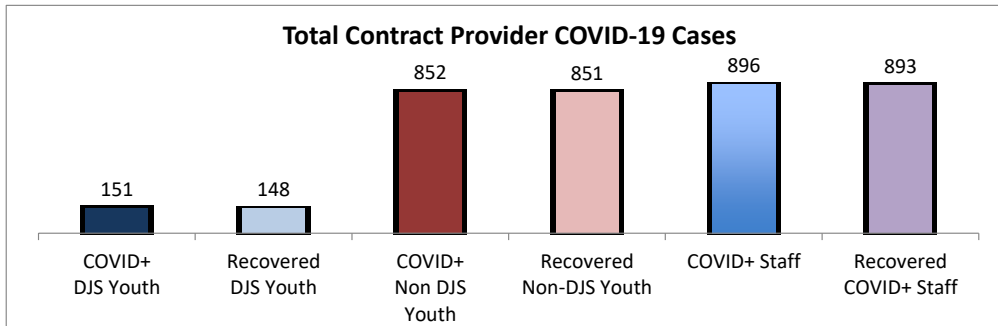


**Overall COVID19 Cases To Date, May 1, 2023**
