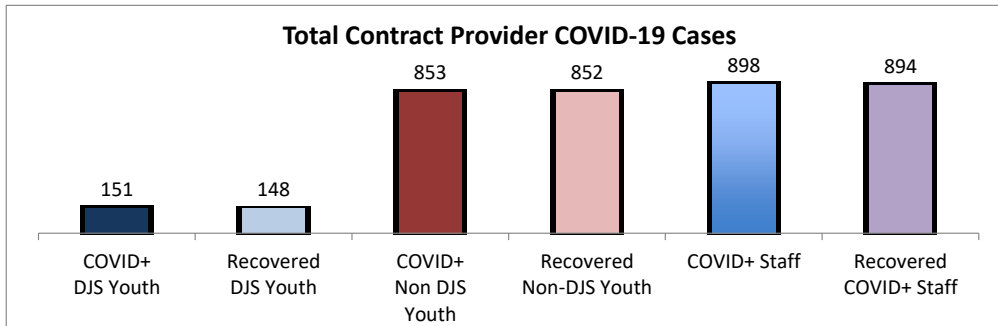


**Overall COVID19 Cases To Date, July 17, 2023**
