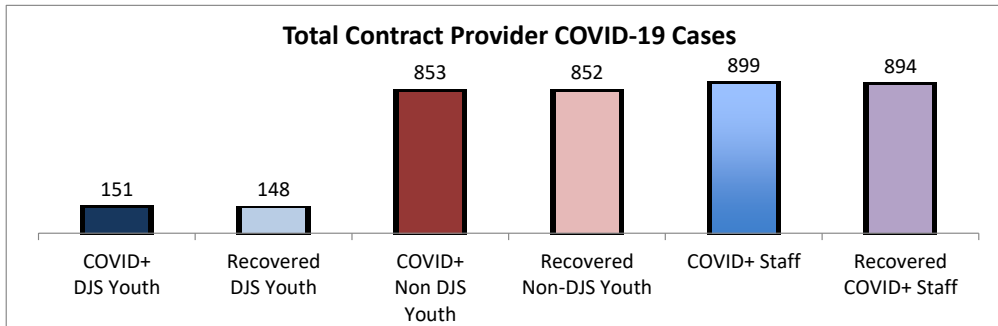


Overall COVID19 Cases To Date, August 21, 2023
