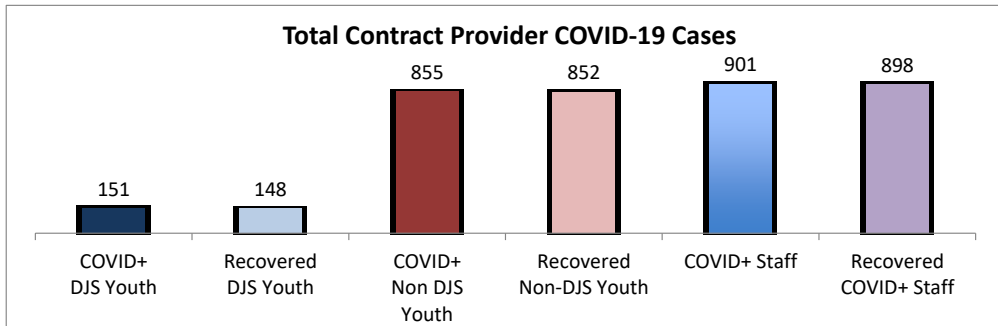


Overall COVID19 Cases To Date, September 5, 2023
