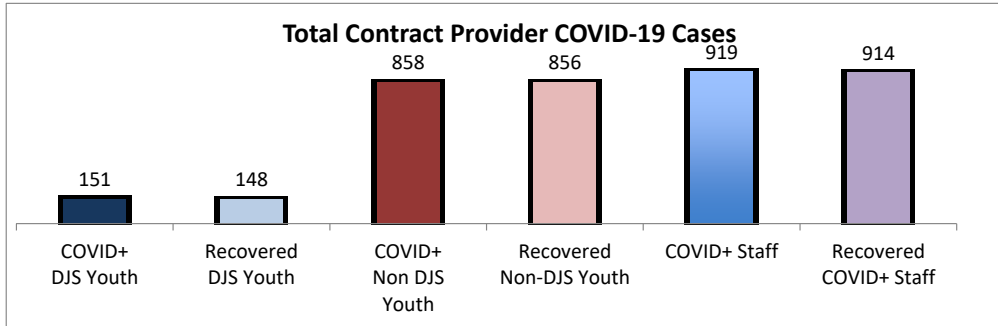


**Overall COVID19 Cases To Date, November 20, 2023**
