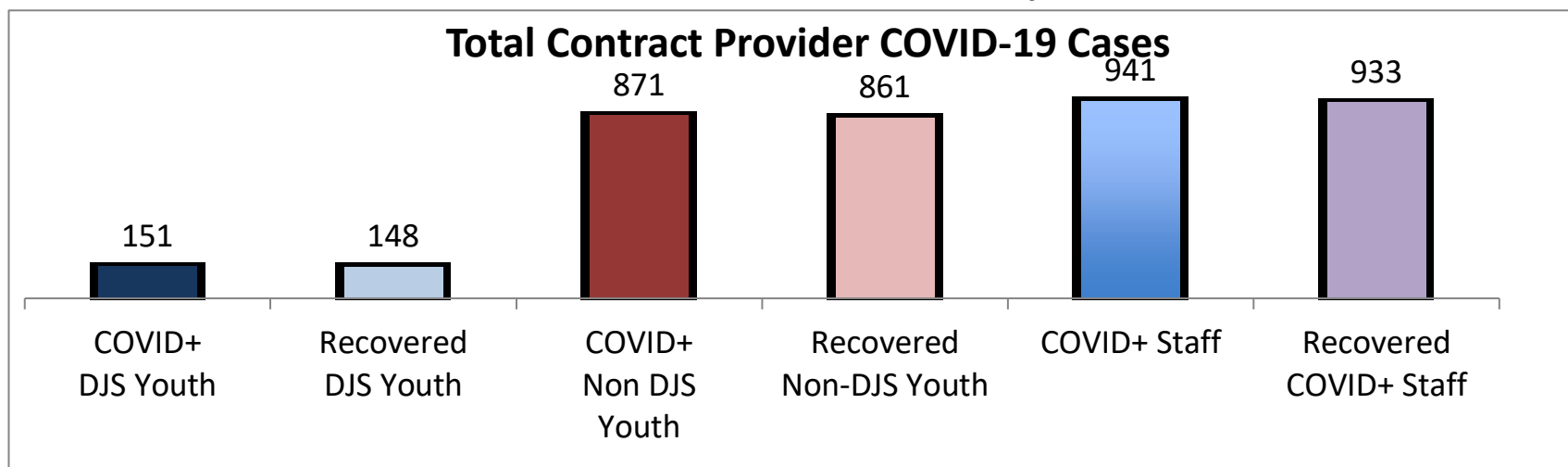


Overall COVID19 Cases To Date, January 22, 2024
