Child in Need of Supervision (CINS) Complaints

In response to the committees' request for population statistics, DJS submits the following data specific to FY 2023 CINS cases by jurisdiction. Total CINS complaints for which CINS was the most serious offense (MSO) are broken out by the subsequent case forwarding decision (resolved, informaled, and formal petition) and then data are also presented to show the total CINS offenses when CINS was part of a complaint but may not have been the most serious offense.
