#### Senator Lee

Is virtual monitoring a new initiative? What juveniles are eligible?

• The various monitoring levels include community detention, phone calls, and in person meetings.

How long does it currently take DJS to get COVID-19 test results - are the tests you use instant or do they have to be processed in a lab – are the same tests used for youth and Staff?

- Results are received in 24-48 hours.
- The same type of tests are used for both youth and staff.

#### LaMar Davis

Can you discuss the actual numbers of youth in facilities who have tested positive for COVID 19?

Have some facilities had more or fewer cases than others?

Has the standard for VOP changed to facilitate the decrease you are seeing?

#### Aisha Braveboy

I just want to thank you for working with us to get placements for youth who we wanted to waive down for disposition in juvenile court. It is very helpful for us to resolve these cases as quickly as possible and DJS's support is critical.

• Increases in the average length of stay may be attributable to the limited operation of the courts.

### Rexanah Wyse

Now that DJS has the data, what strategies will continue to ensure the reduction of youth of color in placement--especially after the state continues its phased openings?

- We do not want to diminish the current rate of reduction.
- High-level individual review has had a positive benefit and is something we want to continue.

• Staff has reinforced that every youth needs different services, this helps to individualize the reviews and we will continue this practice on our end.

### **III.** Fatality Review Update

Jay Johnston Rosemary King Johnston

Rosemary gave background and where we left off in implementing the reviews. Jay gave an update on possible ways to conduct future meetings. We will institute a process to allow secure access to confidential documents and follow the legislative requirements. Unfortunately, we have cases to review. We will schedule meetings in September and October.

• We have internal meetings scheduled and plan to convene the subcommittee in late September and early October. Exact dates will be shared at the next SAB meeting.

Rosemary wants to be sure each case is given enough time to carefully review. Robin stated that this might be a good opportunity to look back the last few years and compare. Rosemary thanked him for the suggestion.

### IV. Juvenile Justice Monitoring Unit Report

Nick Moroney

Nick Moroney reported:

- COVID-19 reinforced the importance of having all the things that are needed to ensure health and safety.
- Emphasis should be placed on the best interest of each youth.
- DJS is maintaining those processes and plans for them to continue.
- Both mental and physical health must be considered.
- Would like to see a continuance of the technology available for teaching; there are some issues with Chromebook, and would like to see more of an implementation plan from MSDE.

Rosemary thanked the Board members for the education discussion, expressed a shared concern that youth are being short changed, and a concern with the lack/quality of instruction during COVID-19

Deborah thanked the group for their concerns, stated that MSDE/ JSES has a plan and will take back the expressed concerns, indicated they are putting a plan into place with Chromebooks, and training with DJS. Once the plan is approved, it will be shared with SAB.
