Audit Findings

Audit Narrative

PREA America's services were retained on November 20, 2017, to conduct the PREA audit of Meadow Mountain Youth Center. Notices of the audit went up 6 weeks in advance of the on-site audit, informing residents of how to confidentially contact the auditor. The on-site audit began at 6 a.m. on May 24th as scheduled. The audit team consisted of DOJ Certified PREA Auditor Will Weir and PREA America Project Manager Tom Kovach. Superintendent Todd Bowman, Assistant Superintendent (and facility PREA Compliance Manager) Corey Marshall and agency PREA Coordinator Aaron Keech met with the audit team for an introductory briefing before conducting a tour of the facility and grounds. Interviews, especially of overnight staff, began right away, as well. In total, 18 staff and administrative interviews were conducted for this audit. 5 of these were interviews of agency officials, sometimes conducted by phone. 6 of these were specialized staff, and 7 were random staff interviews. Staff were randomly selected from all shifts. 11 of the 23 residents were interviewed, 5 of these being targeted interviews (as defined by the PREA Auditor Handbook) of youth who may have indicated a risk factor during the facility's screening for risk of victimization. Youth were randomly selected from all living areas.

Agency administrators were interviewed by phone, or in person, before or after the on-site audit. These interviews included: Deputy Director of Operations Linda McWilliams, Acting Director of Quality Assurance Gregory Lane, PREA Coordinator Aaron Keech, Human Resources Director Phillip Deitchman, and Acting Director of Investigations Jeffery Kessler.

The Exit Briefing was attended by Superintendent Todd Bowman, Assistant Superintendent (and facility PREA Compliance Manager) Corey Marshall, and agency PREA Coordinator Aaron Keech. Deputy Secretary of Operations Linda McWilliams and Executive Director of Residential Services Anthony Wynn joined the meeting by speaker phone. Several topics were covered during the briefing to update officials of the progress of the audit and answer questions. Although the auditors had more work to do and documents to review, they had no requirements for additional proof of compliance from MMYC at this point in the process. Investigations of sexual abuse and sexual harassment appear to be done very well, and redundancy is build into the screening and monitoring processes. The audit team also reported that the feedback from residents has been positive for PREA compliance in all the areas about which they were questioned. Residents who have been involved in investigations have provided indications that the PREA Standards have been followed. Additionally, residents report that staff are attentive, and that staff teach residents skills that help them to manage their emotions and to solve problems appropriately. Youth reported no violations of confidentiality and no inappropriate searches. Any resident with difficulties, such as a learning disability or limited English proficiency, can get the help they need. Youth even know about outside advocacy for survivors of sexual abuse, and they verified that PREA education and screening is completed right away upon their arrival at MMYC.

MMYC has developed, documented, and made its best efforts to comply on a regular basis with, a staffing plan that considers all relevant factors, and provides for adequate levels of staffing and video monitoring, to protect residents against abuse. The average daily number of residents is 25. The average daily number of residents on which the staffing plan was predicated is 40. According to the Pre-Audit Questionnaire, interviews, and other documentation received by the auditor, there were no deviations from the plan in the past year. However, if there had been any, there would have had to have been documentation by the facility and justification for each such deviation. The facility's plan strives to maintain staffing ratios of a minimum of 1:8 during resident waking hours and 1:16 during resident sleeping hours. At least once every year, the agency or facility, in collaboration with the PREA Coordinator, reviews the staffing plan to see whether adjustments to it are needed. They also annually review the following: prevailing staffing patterns; the deployment of monitoring technology; and the allocation of agency or facility resources to commit to the staffing plan, to ensure compliance with the staffing plan. The facility requires that intermediate-level or higher-level staff conduct unannounced rounds to identify and deter staff sexual abuse and sexual harassment. These rounds are documented and cover all shifts, according to logs provided and interviews conducted. From the information reviewed by the audit team, and interviews, it appears the facility often exceeds the staffing ratios and does more than the minimum number of unannounced rounds.

MMYC does not conduct cross-gender searches of residents, absent exigent circumstances. In the past 12 months, no cross-gender searches have been performed; but had they been, documentation would have been required. Policy and procedures on these matters were reviewed by the auditor and discussed during interviews with staff and residents. The facility has implemented policies and

procedures that enable residents to shower, perform bodily functions, and change clothing without non-medical staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine room checks (including via video camera). Policies and procedures require staff of the opposite gender to announce their presence when entering a resident housing unit or area where residents are likely to be showering, performing bodily functions, or changing clothing. The facility has a policy prohibiting staff from searching or physically examining a transgender or intersex resident for the sole purpose of determining the resident's genital status. None of these searches have occurred in the past 12 months. Documentation and interviews indicate that all staff have been trained regarding searches, and that all staff understand the training. Training Curricula were provided by the facility and reviewed by the auditor, and training logs were provided and reviewed. Residents report no searches or cross-gender supervision they consider to be inappropriate.

According to the Pre-Audit Questionnaire, a review of policy, and interviews conducted, MMYC has established procedures to provide disabled residents, and residents with limited English proficiency (LEP), equal opportunity to participate in or benefit from all aspects of the agency's efforts to prevent, detect, and respond to sexual abuse and sexual harassment. Policy prohibits use of resident interpreters, resident readers, or other types of resident assistants, except in limited circumstances, where an extended delay in obtaining an effective interpreter could compromise the resident's safety, the performance of first-response duties under \(\mathbb{G} \) 115.364, or the investigation of the resident's allegations. The agency would document any of the limited circumstances in individual cases where resident interpreters, readers, or other types of resident assistants were used; but in the past 12 months, there have not been any such instances. Exceeding the minimum requirement of the standard, the agency provides contract interpreters all day for LEP residents, not just when there is a required need. Interpreters accompany the youth to class and assist them in various ways throughout the day.

The Maryland Department of Juvenile Services conducts criminal background checks on all potential employees and checks the central registry of abuse and neglect. In addition, the Maryland Department of Juvenile Justice overarching policy that must be followed by public and contracted facilities requires this. Phillip Deitchman, Human Resources Director, explained that before being hired the prospective employee gets interviewed by an investigator, and by a psychologist. They then get a CAR check and Fed/State Background check, which provide continual updates for any violations, including motor

vehicle violations/tickets. Policy reviews, interviews, and reviews of random employee files verify the agency significantly exceeds the minimum standard.

Administrative investigations are typically conducted by the Office of the Inspector General, and by Child Protective Services. They coordinate on the criminal investigations typically completed by the Maryland State Police. The police follow uniform evidence protocol. Where possible, examinations are conducted by Sexual Assault Forensic Examiners (SAFEs) or Sexual Assault Nurse Examiners (SANEs). When SANEs or SAFEs are not available, a qualified medical practitioner performs forensic medical examinations. The facility documents efforts to provide SANEs or SAFEs. During the past 12 months, there have been no forensic medical exams conducted. The facility attempts to make a victim advocate from a rape crisis center available to the victim, in person or by other means, and documents these efforts. If and when a rape crisis center is not available to provide victim advocate services, the facility provides a qualified staff member from a community-based organization or a qualified agency staff member. Although he or she does not conduct forensic exams, there is a Registered Nurse that has had PREA training on the grounds of MMYC Monday-Friday, 8 hours per day. Forensic exams are conducted at Western Maryland Health Systems, Cumberland, MD.

In the past 12 months, there have been 5 allegations or suspicions of sexual abuse or harassment received and fully investigated. The agency has a policy that requires that allegations of sexual abuse or sexual harassment be referred for investigation to an agency with the legal authority to conduct criminal investigations, unless the allegation does not involve potentially criminal behavior. The agency's policy regarding the referral of allegations of sexual abuse or sexual harassment for a criminal investigation is published on the agency website. PREA Compliance Manager Corey Marshall verifies that all referrals of allegations of sexual abuse or sexual harassment for criminal investigation are documented. Other interviews, policies reviewed, along with investigative documentation, and an interview with an investigator, also verify agency and facility compliance with this standard.

MMYC's training curriculum was provided by the facility and reviewed by the auditor. MMYC trains all employees who may have contact with residents on the following required matters: The zero-tolerance policy for sexual abuse and sexual harassment; How to fulfill their responsibilities under agency sexual abuse and sexual harassment prevention, detection, reporting, and response policies and procedures; Residents' right to be free from sexual abuse and sexual harassment; The right of residents and employees to be free from retaliation for reporting sexual abuse and sexual harassment; The dynamics of sexual abuse and sexual harassment in juvenile facilities; The common reactions of juvenile victims of sexual abuse and sexual harassment; How to detect and respond to signs of threatened and actual sexual abuse; How to distinguish between consensual sexual contact and sexual abuse between residents; How to avoid inappropriate relationships with residents; How to communicate effectively and

The training teaches how to detect and assess signs of sexual abuse and sexual harassment; how to preserve physical evidence of sexual abuse; how to respond effectively and professionally to juvenile victims of sexual abuse and sexual

MMYC has a policy that requires screening upon admission for risk of sexual abuse victimization or sexual abusiveness toward other residents, using an objective screening instrument, within 24 hours of their intake, significantly exceeding the standard which requires this be done within 72 hours. These specific screenings are referred to as Vulnerability Assessment Instruments. Among the ways MMYC exceeds this standard are that these Vulnerability Assessment Instruments, according to interviews, generally are actually typically done within the first few hours of the residents' arrival; and, additional screening instruments are engaged. Also, the policy requires that a resident's risk level be reassessed periodically throughout their confinement. When reassessments are done, a housing reassessment is also completed. The auditor viewed examples of the screening instruments and spoke with staff involved in the intake/admissions process. The screening instruments attempt to glean relevant information relating to risk beyond the minimum requirements under this standard. Interviews conducted during the onsite audit, including interviews with residents, indicate quality screenings and reassessments are being done, and that there is a high level of confidence the information is properly used and properly protected. Classification of Youth in DJS Residential Facilities (Policy Number RF-716-18), states, in Section III A (6), "Copies of the completed VAI and the Housing Classification Assessment Forms shall be placed in the youth's base file. The information obtained from the classification and VAI assessments shall be shared only with designated staff who have a need to know. Staff shall ensure confidentiality of all youth information."

MMYC has established procedures allowing for multiple internal ways for residents to report privately to agency officials about sexual abuse and sexual harassment; retaliation by other residents or staff for reporting sexual abuse and sexual harassment; and staff neglect or violation of responsibilities that may have contributed to such incidents. Residents can report verbally, through the grievance process, or through the outside reporting options. The facility does not house any residents detained solely for civil immigration purposes, so parts of this standard are non-applicable. The agency has a policy mandating that staff accept reports of sexual abuse and sexual harassment made verbally, in writing, anonymously, and from third parties. The agency has established procedures for staff to privately report sexual abuse and sexual harassment of residents. The flyer provided to youth and posted round the facility states, in part:

SEXUAL ABUSE HOTLINE DIAL 211

The Department of Juvenile Services has a ZERO TOLERANCE Policy for any form of sexual abuse or sexual harassment. Sexual activity is prohibited. If you feel threatened or are fearful of harm report it immediately. You can tell your case manager, unit staff, medical staff, teachers, supervisors, child advocate, your parent or guardian, or any other trusted adult. Your concerns will be addressed promptly

in a professional manner. You may also report sexual abuse and sexual harassment using the Sexual Abuse Hotline. The Sexual Abuse Hotline was created so that you will be able to report sexual abuse or sexual harassment confidentially. The Hotline is an outside agency that will receive your concern and ensure that it is reported to Child Protective Services for investigation. The Hotline will also inform the Department of Juvenile Services so that steps can be taken immediately for your protection. It is important to us that you are safe and free from all types of abuse during your placement. The Sexual Abuse Hotline is available 24 hours each day, 7 days a week.

If you have been, or know someone who may have been abused or harmed, tell a trusted adult immediately or call the Sexual Abuse Hotline by dialing 211.

MMYC has an administrative procedure for dealing with resident grievances regarding sexual abuse which allows a resident to submit a grievance regarding an allegation of sexual abuse at any time, regardless of when the incident is alleged to have occurred. The agency policy does not require a resident alleging an incident of sexual abuse to use an informal grievance process, nor otherwise to

attempt to resolve it with staff. Not only do policy and procedure allow a resident to submit a grievance alleging sexual abuse without submitting it to the staff member who is the subject of the complaint; but further, the policy requires that such a grievance not be referred to the staff member who is the subject of the complaint. While the system is set up to accept grievances alleging sexual abuse, once these grievances are received, they are handled according to PREA policy, rather than continuing to be processed totally within the grievance system. Policy OPS-907-15 states, in the first paragraph, "The Department of Juvenile Services (DJS) shall ensure youth and individuals acting on behalf of DJS youth can file a grievance for a situation related to behavior of other youth or staff, contractors or volunteers, or to the conditions of confinement. If the youth initiates a grievance alleging abuse, neglect, sexual abuse or mental injury, the Department's Youth Advocacy Unit will not handle that grievance but will instead report the incident to Child Protective Services (CPS), the Maryland State Police, and the DJS' Office of the Inspector General (OIG) for immediate investigation. Grievances do not replace staff responsibility for reporting abuse, neglect, sexual abuse or mental injury." Then, on page 5 of the policy, Direct Care Staff Responsibilities include, "Report allegations of sexual abuse or harassment in accordance with the DJS PREA - Elimination and Reporting of Sexual Abuse and Harassment Policy and Procedures, if the youth indicates to the staff that this subject is the nature of the grievance." Since sexual abuse and harassment allegations are reported outside the grievance system, the grievance system timelines do not apply to these types of allegations. However, there is a protocol on page 7 of this policy regarding emergency grievances which "must be resolved within eight hours of receipt. A verbal response must be followed with a written response within 48 hours of receipt to the youth and the Director of the Youth Advocacy Unit." Policy and procedure permits third parties, including fellow residents, staff members, family members, attorneys, and outside advocates, to assist residents in filing requests for administrative remedies relating to allegations of sexual abuse, and to file such requests on behalf of residents. Agency policy and procedure require that if the resident declines to have third-party assistance in filing a grievance alleging sexual abuse, the agency documents the resident's decision to decline. The written policy limits the agency's ability to discipline a resident for filing a grievance alleging sexual abuse to occasions where the agency demonstrates that the resident filed the grievance in bad faith.

Staff and residents interviewed knew that reports can be received through other people, even through people outside the facility; that reports can be made anonymously; and that reports can be made through outside organizations. The agency and facility publicly distribute information on how to report resident sexual abuse or sexual harassment on behalf of residents. Information is provided to the resident and family. Posters list the CPS toll-free number and other reporting options, the information is included in youth and staff training, and the information is listed on the Maryland Department of Juvenile Services Website.

According to the Pre-Audit Questionnaire, in the past 12 months, there have been 5 times the facility determined that a resident was subject to substantial risk of imminent sexual abuse. The facility treats every allegation as a potential substantial risk situation. Compliance was established with a review of documents, policy, and interviews, including the interviews with PREA Compliance Manager Corey Marshall and PREA Coordinator Aaron Keech.

MMYC has a policy to protect all residents and staff who report sexual abuse or sexual harassment, or who cooperate with sexual abuse or sexual harassment investigations, from retaliation by other residents or staff. Exceeding the minimum requirements of this standard, the agency designates duplicate administrative staff with official duties of monitoring for possible retaliation. This is in addition to mandating that everyone keeps possible retaliation in mind. PREA Compliance Manager Corey Marshall monitors the conduct and treatment of residents or staff who reported sexual abuse, and of residents who were reported to have suffered sexual abuse, to see if there are any changes that may suggest possible retaliation by residents or staff, for 90 days or as long as needed. Also exceeding the requirement of this standard, this monitoring must be done and documented on a weekly basis. The facility acts promptly to remedy any such retaliation. No incidents of retaliation are known to have occurred in the past 12 months.

There are protocols in policy for youth who indicate risk of being victimized or abusive. This includes housing decisions regarding any youth who may be alleged victims of sexual abuse. These protocols start upon the youth's arrival at MMYC and are updated by information received from and about each youth, and the youth's behavior. Guidelines for administrators are covered in the MMCC FOP for Housing At-Risk Youth. Section B of this FOP states, "Placement of Youth in Housing, Bed, Program, Education, and Work Assignments:

- 1. The Department shall use all information obtained in the initial classification and any information obtained thereafter to make housing, bed, program, education, and work assignments for residents with the goal of keeping all residents safe and free from all forms of abuse.
- 2. Youth may be separated from others only as a last resort when less restrictive measures are inadequate to keep them and other youth safe and then only until an alternative means of keeping all youth safe can be arranged. During any period of isolation, youth shall not be denied daily large-muscle exercise, and any legally required educational programming or special education services. Youth shall be seen daily by medical and mental health care staff. Youth shall also have access to other programs and work opportunities to the extent possible. If a youth is isolated, the administrator must document in the youth's file the basis for the concern for the youth's safety, and the reason why no alternative means of separation can be arranged.
- 3. The facility administrator shall ensure that each youth separated from the general population is reviewed every 30 days to determine whether there is a continuing need for the separation.
- 4. Lesbian, gay, bisexual, transgender, or intersex youth shall not be placed in particular housing, bed, or other assignments solely based on such identification or status, nor shall lesbian, gay, bisexual, transgender, or intersex identification or status be considered as an indicator of likelihood of being sexually abusive.
- 5. Transgender and intersex youth shall be given the opportunity to shower separately from other youth.
- 6. In deciding whether to assign a transgender or intersex youth to a facility for male or female youth, and in making other housing and programming assignments, the facility administrator shall consider on a case-by-case basis whether placement would ensure the youth's health and safety, and whether the placement would present management or security problems.
- 7. Placement and programming assignments for each transgender or intersex youth shall be reassessed twice a year to review for any threats to safety experienced by the youth. A transgender or intersex youth views with respect to his or her safety shall be given serious consideration.
- 8. Staff shall provide heightened protection and supervision of vulnerable youth and youth who have been a victim of sexual abuse or harassment."

The auditor received information from youth who had been alleged victims of abuse/harassment, and reviewed documentation as well. It appears that in the past 12 months alleged victims were kept safe without the use of isolation. Youth were interviewed who stated they have been separated from other youth temporarily due to rule violations such as fighting. The said staff try to resolve problems quickly and get youth to talk it out. Also, youth were interviewed who are considered to have risk factors that may make them vulnerable to abuse. Documentation reviewed, and interviews conducted, indicate the facility follows this standard in ways specific to these populations.

MMYC has a policy related to criminal and administrative agency investigations. The agency does not terminate an investigation solely because the source of the allegation recants the allegation. The substantiated allegations of conduct that appear to be criminal are referred for prosecution. The agency retains all written reports pertaining to the administrative or criminal investigation of alleged sexual abuse or sexual harassment for as long as the alleged abuser is a resident or is employed by the agency, plus five years. The Office of the Inspector General usually conducts the facility's administrative investigations. Interviews, and a review of investigative documentation, indicate they do these investigations promptly, thoroughly, and objectively for all allegations, including third-party and anonymous reports. These administrative investigations include an effort to determine whether staff actions or failures to act contributed to the abuse, and the investigations are documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings. When the quality of evidence appears to support criminal prosecution, the agency will conduct compelled interviews only after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution. The credibility of an alleged victim, suspect, or witness is assessed on an individual basis and not determined by the person's status as resident or staff. The departure of the alleged abuser or victim from the employment or control of the facility or agency does not provide a basis for terminating an investigation. No resident who alleges sexual abuse will have to submit to a polygraph examination or other truth-telling device as a condition for proceeding with the investigation of such an allegation. When outside agencies investigate sexual abuse, the facility cooperates and endeavors to remain informed about the prog

unsubstantiated, or unfounded following an investigation. In the past 12 months there have been 5 investigations of sexual abuse or harassment, and the alleged victim was informed of the outcome of the investigation in each case. If an outside entity conducts an investigation, the agency requests the relevant information from the investigative entity in order to inform the resident of the outcome of the investigation. Following a resident's allegation that a staff member has committed sexual abuse against the resident, the facility subsequently informs the resident (unless the facility has determined that the allegation is unfounded) whenever: the staff member is no longer posted within the resident's unit; the staff member is no longer employed at the facility; the agency learns that the staff member has been indicted on a charge related to sexual abuse within the facility. Following a resident's allegation that he or she has been sexually abused by another resident in an agency facility, the agency subsequently informs the alleged victim whenever the agency learns that the alleged abuser has been indicted or convicted on a charge related to sexual abuse within the facility. The agency has a policy that all notifications to residents described under this standard are documented. PREA Compliance Manager Corey Marshall states that MMYC compiles accurate, uniform data for every allegation of sexual abuse, using a standardized instrument and set of definitions, and provides this to the State of Maryland at least annually. The facility maintains, reviews, and collects data as needed from all available incident-based documents, including reports, investigation files, and sexual abuse incident reviews. PREA Coordinator Aaron Keech also verifies and explains this process, describing a system with proper oversight and integrity to justify a high degree of confidence in the reliability of their data.
